The certification has been renewed in date: 17/12/2020 with expiry date: 16/12/2023.

In January 2021 SIAPI has informed the Certification Authorities regarding the change of Company Name in SIAPI SMARTECH srl.

The Policy for the Environment, defines the objectives of the environmental impacts, through a continuous engagement and training of all the employees, creating the basis for an industrial culture that identifies the respect for the Environment as a priority value. In order to achieve these results and to realize this strategic choice, Siapi Smartech has been adopting since 2008 an Environment Management System, which has been updated according to the UNI-EN-ISO 14001:2015. The process of certification with the new regulation has been positively accomplished in date 17/12/2017.

The certification has been renewed in date: 17/12/2020 with expiry date: 16/12/2023.

Following to the sale of a company branch and the consequent reduction of the environmental impacts, SIAPI SMARTECH has decided not to renew the certification, while maintaining the control of the processes with regard to the environmental aspects.

The Policy for the Health and Safety in the workplaces, has always been pursued, in the full respect of all the regulations of the industrial field; it constitutes an essential element of corporate processes able to guarantee the best possible working conditions to all the employees, the cooperators and the suppliers of goods and services entering into contact with our facilities.
